(Delivered on 20<sup>th</sup> September 2024)

01. The reporting trustee has filed present change report on dated 31/05/2024 under section 22 of the Maharashtra Public Trust Act, 1950, for the change occurred in the General

The reporting trustee has filed various documents on record i.e. copy of delay application vide Exh. 02, copy of issue notice vide Exh. 03, copy of affidavit of process server vide Exh. 04, copy of consent letter vide Exh.09, copy of no objection letter vide Exh. 10, copy of notice of General body meeting dated 01/02/2018 vide Exh. 11, copy of minutes of General body meeting dated 03/03/2018 vide Exh. 12, copy list of membership vide Exh. 13, copy of rules and regulations vide Exh. 14, certified copy of Schedule-I vide Exh. 15, certified copy of Schedule-X vide Exh. 16, etc.

03. He has submitted that the election of executive body members and election of office bearer are hold in the general meeting. He has submitted that, the above said change report is made as per the rules and regulation of the trust and the above said





change report is legal and valid and lastly he has prayed that, the above said change report may kindly be accepted.

04. The reporting trustee has examined himself by the way of affidavit vide Exh. 08 in the support of his claim and contention and she has filed evidence closed pursis vide Exh. 17. The reporting trustee has argued the matter by orally. Delay application vide Exh.02 is allowed by this court subject to cost of Rs. 2,000/- and said costs of Rs. 2,000/- is deposited in the P.T.A. Fund of this office on dated 16/08/2024, accordingly delay is condoned. The reporting has submitted that, the above said change report is made as per rules and regulation of said trust and the above said change report is legal and valid and lastly the reporting trustee has argued that the reported change may kindly be accepted.

05. After going through documents placed on record, evidence and argument of reporting trustee, following points arise for my determination and I have recorded my findings against each points and reasons stated below:-

06. 10. Perused the record of said trust and the record of said matter, it is clear that, the outgoing trustee and incoming trustees of said change report are same as per schedule-I of said trust. Perused the record of election of said trust it is crystal clear

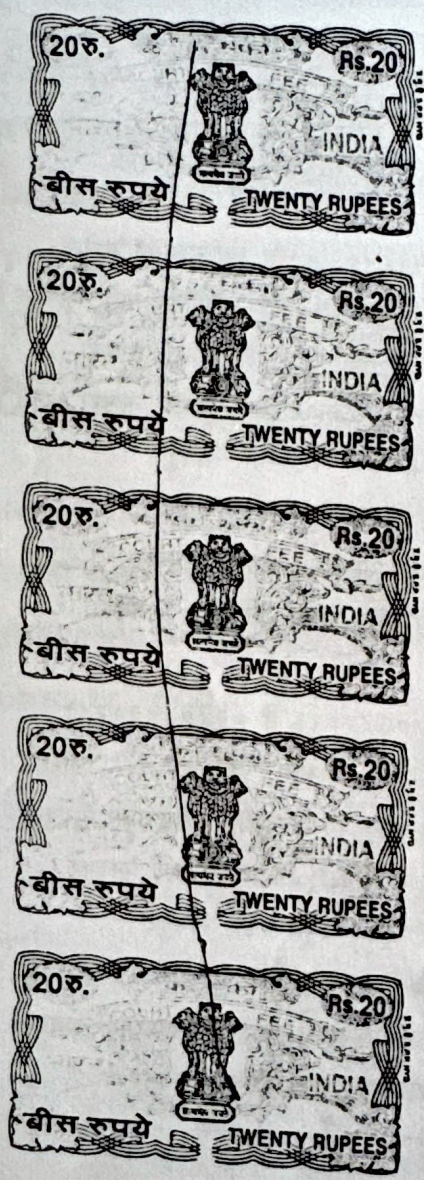
